VISA GUIDANCE NOTES



Persons requiring a Visa to enter Jamaica must submit the following documentation:

1. One (1) recent passport sized photo.
2. Valid passport (validity must cover the period of travel to and from Jamaica) with at least 6 months before expiry.
3. Your immigration status confirmation (E-VISA share code)
4. Flight reservation (round trip itinerary must terminate in the country where you currently reside) and Hotel reservation confirmation (if staying in a hotel) or proof of where you will be staying, e.g. a signed invitation letter from a friend/family with name, address, telephone number and e-mail address.
5. Bank statements for the last three (3) months as proof that sufficient funds are available for the visit
6. Proof of visa(s) or other permit(s) to transit countries on your flight itinerary en route to and from Jamaica
7. In the case of minors also travelling, full birth certificates/ adoption order/ custody order must be presented together with a letter of consent from parent/guardian and the passport of parent/guardian. If travelling with a spouse, a marriage certificate may be required.
8. For students, a letter from your educational institution in the country where you live confirming your status OR letter of acceptance/invitation from educational institution in Jamaica if you will be travelling to Jamaica for academic purposes.
9. Confirmation of employment from employer
10. Proof of ownership if you are a business owner or self-employed.
11. Proof of Jamaican work permit letter OR work permit exemption letter from the Ministry of Labour & Social Security in Jamaica if you intend to work in Jamaica or to volunteer with a church or non-profit/charitable organisation in Jamaica. *This is also required for Internships whether paid or unpaid.*
12. Letter of invitation from organisation in Jamaica if travelling for business, conference, meeting, cultural exchange or activity.

Payment Information

- An invoice for payment will be sent to you via email once the initial application is processed. All fees are payable via Bank Transfer to the Jamaican High Commission. Please note the fee is non-refundable and no cash payments are accepted.
- Payment receipts / transfer confirmations must be submitted before final processing of the application.

Port of Entry Visa Applications and Other Charges

A Port of Entry Visa may only be granted to persons who are eligible under Jamaican immigration regulations and who satisfy the Immigration Officer upon arrival in Jamaica.

Port of Entry Visa	US\$100.00
Persons arriving in Jamaica without the required visa	US\$350.00
Extension of stay beyond the visa exemption period	JM\$50,000.00
Regularisation of overstay	JM\$50,000.00

Processing Times

Actual processing time is approx 15 - 20 business days after being invoiced

For applications delivered in person, please allow at least three (3) business days for processing.

If the visa application has been referred to Jamaica for approval, or has been submitted by post, please allow at least 2–3 weeks for processing. Your passport and relevant document(s) will be returned to you by RM Special Delivery.
